Parent Policies & Procedures Agreement Form 2022-2023:

Costumes/Shoes/Tights:

_____ Measurements will be taken by Miss Tina during the month of October. I understand that the dance costumes ordered are not custom made for my child & some alterations may be needed at my (the parent) expense, since there is no sure way to gauge how much each child will grow.

_____ I understand that if my costume fees are not paid for by October 1st (1st half) & November 1st (2nd half), I will need to sign a grace period contract before the costumes are ordered.

_____ I understand that if I choose to discontinue classes, costume fees will **NOT be refunded**. Costumes can be picked up from the studio for personal use once they have been delivered.

_____ I understand that a wiglet fee will be charged to my dance account in December (\$55) for all dancers in the Pre-School, K-1st Grade & 2nd-4th Grade Recreational Lines & the Performing Line POSSE line & that Miss Tasha will color match each dancer to the best of her ability.

_____ I will order & purchase all required shoes through Vogue Dance Company before Picture Weekend &/or Pre-Comp.

_____ I will purchase all required tights through Vogue Dance Company (available in March) before Picture Weekend &/or our first competition.

Tuition:

_____ I will notify & confirm with Miss Tina &/or Tasha immediately if I choose to discontinue any classes at any time, and I am aware that I am responsible for any fees owed at that time.

_____ I understand that tuition is to be paid on a monthly basis regardless of the numbers of weeks per month. There will be no make-up classes or credits given for missed classes due to competitions, illnesses, holidays, vacations, Covid-19 &/or snow days.

_____ I am aware that the monthly tuition is a 10-month payment program and is due by the 10th of every month (September – June).

_____ I am aware that a \$25 LATE FEE will be charged to my account for monthly tuition fees that are not paid in full by the 10th of each month. * If your account is in arrears for a consecutive 30 days there will be a grace period contract that will need to be signed by the owners and parent/guardian. If that grace period contract is not fulfilled, Vogue Dance Company reserves the right to discontinue all or any classes.

Competition fees: (Performing Line Parents only)

_____ I understand that if I do not have my competition fees paid for by the defined due dates, my child will not be registered for that/those competitions. If your competition fees get paid AFTER the defined due dates, there will be an additional \$25 late fee charge per dance as charged by the competitions. * If you need to fill out a grace period contract prior, please contact Tina or Tasha. If that grace period contract is not fulfilled, Vogue Dance Company reserves the right to discontinue all or any classes.

_____ All NSF checks will be charged additional \$35.00

_____ I give Vogue Dance Company permission to use my picture or my child's picture for advertising & promotional purposes.

_____ I hereby release all persons affiliated with Vogue Dance Company from any and all claims for damages or injuries, which may be sustained while participating in any and all activities connected with Vogue Dance Company.

_____ I am aware that all class times are subject to change and cancellation due to class enrollment. A *minimum of 5 students* is required for each class to continue or the class will be cancelled.

_____ Vogue Dance Company reserves the right to close a class due to the class size at any time (stop accepting dancers due to a large number of dancers enrolled in the class).

Registration Fees: \$35 for one dancer & \$60 for a family.

This fee reserves your dancers' placement in his/her class for the 2022-2023 dance season. Registration fees are due at the time of enrollment and are non-refundable, no exceptions!
